



Stockdale Watermelon Jubilee Food Vendor
Application & Rules
June 20th & 21st 2008

Thank you for your interest in the 2008 Stockdale Watermelon Jubilee. Attached is the application form for 2008 Vendors. Please read all the rules and regulation before filling out application and signing. You must have all three requirements/steps complete in order to participate.

1. REGISTRATION: The Food Booth Fee is **\$100.00 for each day** – Friday and Saturday (\$200 total if you plan to sell both days). This fee needs to be payable to the Stockdale C of C per money order.

2. Food Vendors License Fee: You must also purchase a food vendor license from the City of Stockdale. The Cost is \$25.00 and may only be purchased at the Stockdale City Hall. **(THIS IS NOT INCLUDED IN THE FEE FOR THE BOOTH)**

3. FOOD HANDLERS PERMIT: A food handler's permit is also required in addition to the two fees above. You need to contact the Wilson County Health Department to get your study guide and schedule your **TEST**. You can reach them at (830)393-7346 or go by 2 Library Lane, Suite #4 in Floresville, TX. This must be taken care of prior to setting up and selling food from your booth. The Health inspector will be at the festival to insure that you have your permit. **You must have the FOOD HANDLERS PERMIT to be able to serve/sell food!**

RULES/REGULATIONS

1. **NO** prepackaged beverages may be sold. (Beer, wine, water, sodas, etc) You may serve Homemade Lemonade and Ice Tea.
2. One 110 electrical outlet will be available per booth. If you need more than the one offered you will need to supply your own. You will need to bring your own extension cords.
3. The jubilee is held rain or shine: please bring necessary materials to keep your products protected.
4. **All fees are non-refundable.**
5. Vendors that fail to cooperate with the rules of the festival, committee members, Jubilee staff or its volunteers may be refused admittance to the event in the future.
6. The Jubilee Committee reserves the right to reject any application for any reason that it deems appropriate.
7. The Stockdale Watermelon Jubilee/Stockdale Chamber of Commerce is not responsible for any items that may be lost or stolen at the festival.
8. Any vendor who attempts to sell items not previously approved may be asked to cease sales of the items or asked to leave the festival.
9. Menu approval must be given prior to festival by committee chair.
10. Vendor is responsible for all supplies needed to build and maintain a safe and clean area.
11. Each vendor will receive **two** arm bands for workers and must be on vendor both nights.
